

- Initiate and implements projects in line with SDGs







Academia and Researchers

To conduct in-depth analysis on advanced science and technological innovations to accelerate the SDG implementation




Private Sector



UN SDG Compass – Guide for businesses and private sector

- 1 Businesses and private companies should be fully understand and aware of SDGs.
- 2 To seize the most important business opportunities presented by the SDGs and reduce risks, companies are encouraged to define their priorities based on an assessment of their positive and negative, current and potential impact on the SDGs across their value chains.
- 3 Aligning the company vision and goals closely with SDGs.
- 4 Integrating sustainability into the core business and governance, and embedding sustainable development targets across all functions within the company. To pursue shared objectives or address systemic challenges, companies increasingly engage in partnerships across the value chain, within their sector or with governments and civil society organizations.
- 5 Businesses and companies to build the SDGs into their communication and reporting with stakeholders.



- To develop and implement business guiding documents with ethical principles
- Comply with all respective laws and regulations, ensure accountability in all business processes and pay taxes responsibly
- undertake initiatives to promote greater environmental responsibility and promote green production
- To provide necessary funding support and commitment towards SDGs
- To provide favorable environment for all employees with good incentive and capacity building opportunities
- To advocate and lead "positivity" (Corporate Governance Development Center of Mongolia)
